If, however, the Underlying closes below the Strike Level, the redemption of the Product will depend on the value of the Underlying, as described in section "Redemption". Due to the buffer feature (Strike Level below Initial Fixing Level) the possible loss of this Product will always be smaller than with a direct investment.
